1. ONGOING BUSINESS-BOARD REPORTS

- **Chair report:** Karen B.
 - The Maryland Center of Excellence on Compulsive Gambling, holds an annual meeting in June, with over 500 addiction professionals attending. Other 12-step groups tabled there but OA was not represented. Karen B. found out that it is free to have a table and proposed BAIG staff a table there next year. This was approved by the meeting and Jane S, PI/PO will take over from here. BAIG has printed materials left over from B'More Healthy Expo in March, these are in Jane's possession. Karen B.

recommended that we purchase the new pamphlets created by World Service as well.

- Karen M brought up that the Kindle version of OA 12 & 12 does not match the printed version and Karen B will contact the World Service Printing Office regarding the issue.
- Joshua D volunteered to staff a table at an upcoming outreach event.
- **Vice Chair report:** no report
- **Secretary:** Connie A., no report apart from May minutes
- **Treasurer:** Karen M.
 - Karen presented the report and Karen B pointed out that the Severna Park meeting was mistakenly included in older treasurers reports but they are not part of BAIG
 - At the last meeting, Alan H in his capacity as Region Rep mentioned that they are changing their prudent reserve policy and suggested it might be a good model for BAIG. Upon review, Karen M suggested that while the new Region model seems helpful, due to turnover in the Treasurer's position, she's not sure of the current level of expenses, which the model is based on. Karen recommends waiting until she has more information, probably later in the year. We also tabled further discussion until Alan H is present to participate.
 - She asked if minutes are available on the website since they provide an important reference for BAIG's decisions. Karen B. said they should be posted. Benjamin D, agreed that they can be posted and archived on the website. He will work with Karen B to get copies of the approved minutes.
 - The Treasurer's Report was approved.
- **Region 7:** Sue B
 - Region 7 has confirmed there will be a one-day virtual convention on November 1st from 9-4. Flyers and additional information will be available soon.
